Right to Food (Scotland) Bill

Introduction

A proposal for a Bill to incorporate the right to food into Scots law.

The consultation runs from 25 November 2021 to 16 February 2022.

Yes, I think and newly created body would provide a very strong message on commitment to alleviate food insecurity and ensure independence across a range of organisations currently engaged in related work. Resourcing will of course be consideration - not just for such a body, but the lack of robust baseline data at a local level constrains improvement activity, and this is impacted by the level of resource locally - both to oversee this work but also among the many community and third sector partners involved. such organisations are largely supported and funded to deliver support and services and often lack the capacity to develop and maintain robust management information, along with requirements for associated development work and reporting requirements.

Increased the need for the Bill

The work around support and crisis response during the pandemic demonstrates that food insecurity is a huge issues and current provision does not reach everyone in need. it is also clear that the support required at the increased level during the pandemic will be required in the longer term as other issues such as the emerging cost of living pressures take affect.

I'd suggest there will be the need for local coordination and oversight, which is likely to lead to the requirement for dedicated resource. as mentioned above, the resource requirements among local partners and organisations delivering support will need to be considered, as well as work to establish baseline data and the means to report progress against that. One further area will be an increased need in food education, so the impact on currently very tight home economics budgets is one area to be considered: costs mean very basic ingredients can not be provided (eg diluting juice used in place of fresh orange in a fruit salad; pupils not having containers to take their food home, depriving them of the potential joy in making food, but also resulting in food waste).

The right to food will ensure that eg religious, health related dietary requirements can be adequately met and also ensure that women and families have dignified access to food: during the pandemic, it has been noted that much of the increase in recipients of food parcels were women, so the proposed bill provides an opportunity to ensure greater equality in the provision of services.
