Right to Food (Scotland) Bill

Introduction

A proposal for a Bill to incorporate the right to food into Scots law.

The consultation runs from 25 November 2021 to 16 February 2022.

As a local councillor in Dundee the Covid-19 pandemic has made clear the need to deal with food insecurity. This was an issue that was clear prior to the pandemic but many more people have now come to recognise that far too many people in our society are going hungry.
